REQUIREMENTS

At time of application, applicants must bring original documents along with photocopies of those documents as proof of completion of high school. Proof of completion documents include the following: High School or G.E.D. Diploma, Transcript, Certificate of Proficiency, or DD-214, are acceptable.

Applicants must be at least 18 years old. Please bring the original and a photo copy to show proof of age at the time of the application. Driver's license, picture I.D., passport or birth certificate are acceptable. Applications must be filled-out at the Training Center.

A VALID Driver's License is required at time of indenture and dispatch to employer.

Applicants must be physically fit to do the work of the trade and will be required to work anywhere within the nine (9) Bay Area Counties. Applicants must be legally authorized to work in the United States.

WRITTEN TEST
ORAL INTERVIEW

Only applicants who successfully pass the written test (Minimum of 70%) will be eligible for the

oral interview.

**ELIGIBILITY LIST** 

Applicants will be placed on the apprentice eligibility list based upon the written examination and

oral interview combined score. Hiring is usually done in January & August each year.
