Beginning July 1, 2020 your Sprinkler Fitter's 483 HRA benefit account has exciting new changes!

You will soon receive a new debit card in the mail that will replace the card you currently have. Your current balance will be automatically transferred to your new account. Important dates regarding the card transition are below, along with exciting new account features.

Your new card offers a dynamic online portal and mobile app that provides simple navigation features with a guided and more personalized experience. You have access to information 24/7 with the ability to view balances and transaction history. You can easily upload documents to substantiate claims and request reimbursement. The HRA debit cards saves you from paying out of pocket expenses up front, and you also have the option to self-enroll in direct deposit for paper reimbursement requests.





Important dates to note during the transition of your HRA account:

- Your current HRA debit cards may be used until June 17, 2020.
- Destroy your old debit card!
- Your new HRA Debit Card(s) will be mailed to your home and are expected to arrive the week of June 22, 2020. Begin using your new card(s) on July 1.

On March 27th, 2020 the CARES Act was signed into law, in light of the impact of COVID-19. As a result, the IRS now allows Over The Counter drugs to be eligible for reimbursement on your HRA plan.
