## Sprinkler Fitters U.A. Local 483 Continuing Education Classes

To sign up for CEC Classes, Download and Use the ISAQR App on your smart phone. Upgrade classes are **RECOMMENDED** 10 hours per year. All Licensed Journeymen need 30 hours of approved classes every 3 years. ALL Courses are Approved and Registered with the CA O.S.F.M.

ASSE 15010 ITM - This is a (40) hour course - This course will cover the Inspection, Testing and Maintenance requirements specified in NFPA 25 CA Ed. (as well as the installation requirements that are not addressed within the standard) for Fire Protection Systems. Best practices (that lack documentation) and tips of the trade will be covered to ensure that the required ITM are safely conducted. The attendee will have the opportunity to acquire the ASSE 15010 certification for ITM by passing both a written and practical exam that goes beyond the NICET certification. This course will consist of (8) classes and (1) test day. Wear HARD HATS, Boots and Work Clothes.

Confined Space - This 16-hour worker course teaches workers about the most common hazards found in confined spaces, and about the OSHA standard that addresses these hazards. Participants also learn about safe entry procedures, monitoring principles, entry permits, ventilation, personal protective equipment and the roles of the entrant, attendant, and entry supervisor. This course includes extensive hands-on training in confined space entry and the use of PPE. Wear HARD HATS, Boots and Work Clothes. CA Approved Course.

Crane Signaling- In this 20-hour course, students will review, demonstrate, and become certified crane signal persons as required by OSHA in 29 CFR §1926 along with ASME B30.3 and B30.5. Learning activities include a combination of practice scenarios along with animations and videos to illustrate the standard hand signals, and crane characteristics/limitations. Once a certified signal person, one's performance as an examiner will be observed and evaluated with a written and practical exam. During the final day, students will review the computer-delivered UA Signal Person Practical Exam process including how to initiate, administer, and conclude test sessions. Wear HARD HATS, Boots and Work Clothes. CA Approved Course.
